What happened, why did it happen?

Online Harassment, Threats to me and my family, Defamation, and Possible Criminal Activity by Samir Drakovac. I don't know the reasons.

Dear Berlin Police Department,

I am writing to urgently report an ongoing case of online harassment, defamation, threats, and suspected criminal activities directed at me and my family by an individual named Samir Drakovac, currently residing in Berlin, Germany. This situation has escalated to the point where I fear for my safety, the safety of my family, and the stability of my professional career.

I kindly ask for your immediate intervention in addressing this matter. Below, I have provided all relevant details, evidence, and context to assist in your investigation.

I am a professional YouTuber with over 400,000 subscribers, a career I have built over the past 12 years, as well as the owner of a digital agency called Amilma Digital (website: amilma.digital). My work is entirely legal, transparent, and visible to both my audience and the authorities.

### 2. Information About the Accused

Name: Samir Drakovac

Origin: Goražde, Bosnia and Herzegovina

Samir Drakovac runs a YouTube channel titled DIJASPORAC (link to channel), which he has been using as a platform to target me with defamatory, abusive, and threatening content for over 76 consecutive days.

### 3. Key Issues and Evidence

#### 3.1. History of Threats

Mr. Drakovac has a documented history of violent threats. Over 15 years ago, he was convicted for threatening a prominent Bosnian journalist, Bakir Hadžiomerović, stating that he would behead him and even offered a reward for such an act. This case is well-documented in public records (source article).

#### 3.2. Current Campaign of Harassment and Defamation

Since October, Mr. Drakovac has livestreamed abusive content on his YouTube channel, specifically targeting me, my wife, and my children. These livestreams include:

Daily insults and slander.

False accusations that I am involved in cyber-criminal activities.

Incitement of his followers to repeatedly file false reports against my YouTube channel, which is my primary source of income.





He has even created a secret Facebook group called Peacemaker to organize up to 300 individuals to systematically report my videos with the intention of triggering YouTube's algorithm to reduce my channel's visibility and income. Evidence of this group exists, and I am willing to share it with you.

3.3. Threats and Suspected Conspiracy to Harm Me  
Recently, I received credible information that Mr. Drakovac allegedly sent €15,000 to an individual in Bosnia and Herzegovina, potentially to harm me or my family physically, or worse, arrange an attack. I reported this to my local police, but no action has been taken so far.

Additionally, during his livestreams, participants in his chat have issued direct threats against me, which he appears to encourage. In one livestream, Mr. Drakovac explicitly suggested that I could be hit by a car, implying a potential fatal incident. Unfortunately, he managed to delete this particular livestream before I could save it, but it is the only missing piece of evidence.

3.4. My Efforts to Resolve the Issue

I have publicly invited Mr. Drakovac to a peaceful conversation on multiple occasions (approximately ten times), hoping to de-escalate the situation and reach an understanding. He has outright refused, once stating that he would not talk to me even for €5 million.

3.5. Professional and Personal Impact

This ongoing harassment has had devastating effects on my personal life and career:

My wife and children have suffered emotional distress due to the constant abuse and public shaming.

My professional reputation is being tarnished through Mr. Drakovac's false claims.

My primary source of income, my YouTube channel (Wiissttaa Live), is under constant attack due to his orchestrated campaigns.

4. My Request for Assistance

I have done everything within my power to address this situation, including reporting the case to my local police. Unfortunately, no action has been taken, and the harassment continues to escalate.

I am now turning to you for help, as Mr. Drakovac resides in Berlin and appears to be using his location to evade accountability. I am willing to:

Provide all evidence, including screenshots, videos, and a detailed timeline of events.

Travel to Berlin if necessary to assist with your investigation.

I am pleading for your intervention in this matter to ensure the safety of my family and myself, as well as to protect my livelihood from further harm. The actions of Mr. Drakovac are not only unethical but potentially criminal, and I believe a thorough investigation is warranted.

Please contact me at your earliest convenience via email or phone so I can provide further information and evidence. I trust in your ability to address this issue appropriately and urgently.
